AFFIDAVIT

The undersigned upon oath deposes and states as follows, to-wit: That I, Josh Seely, am a fulltime, certified, commissioned Deputy in and for Stephens County in the State of Oklahoma. That on 01-08-10 at approximately 1406 I took a report from Dyer, Valerie W/F DOB: 02-11-1984 SSN# 448-82-9572 in reference to her 7 Year old Daughter, HD, disclosing to her that HD's father, DYER, CHARLES ALAN W/M DOB: 08-17-1980 SSN# 444-88-6987, had touched HD in her "no-no spot". In her written statement Dyer states that the first time HD disclosed was a couple of years ago in California. HD told Dyer that while they lived in California her dad Charles would touch her "no-no spot" whenever Dyer would leave to go to the store. Dyer states that she confronted Charles about it and that he stated HD was lying and he would talk to her about it. Dyer states that HD later told her that it was all a dream because daddy had got mad at her and told her mommy was lying. In her statement Dyer states that the second time HD disclosed anything was about four or five months ago. Dyer states that Charles had just got back from California and he was living with his parents. Dyer states that HD would stay with Charles over the weekends. Dyer states that HD told her again that her dad Charles touched her in her "no-no spot". Dyer confronted Charles a second time and he told her that HD was just trying to get him in trouble and that he stumbled over his words. Dyer goes on to write in her report that HD told her that her father, Charles, had again touched her inappropriately over Christmas Break. HD stated to Dyer that every time Daddy's girlfriend would leave he would do it all the time. Dyer states that she asked HD if it hurt and HD told her she didn't know and began to cry. Dyer did not push HD into disclosing any further information. Dyer contacted Law Enforcement and a forensic interview was set for HD at the Mary Abbott house on 01-12-10 at 09:30.

On 01-12-2010 approximately 09:36 hours a forensic interview was conducted on HD, by Jessica Taylor, of the Mary Abbott House. During her interview HD stated that she knew the difference in telling the truth and telling a lie. HD was shown two pictures depicting anatomical drawings of a male and a female. HD was shown, by Taylor, certain

body parts, on these pictures and HD was asked to describe them in her own words. HD described the female body parts as follows: The eyes HD called them Eyes. The Mouth HD called it a mouth. The chest area HD called them boobs. The Belly Button Region HD called the belly button. The vaginal region HD called it the BO-BO. The leg region HD called Legs. The feet region HD called feet. The anal region HD called the Butt. The back region HD called the back The back of the head HD called hair. HD described the male parts as follows: The nasal region HD called it the nose. The Chest region HD called them nipples. The Belly region HD called it the belly button. The penile region HD called it a wiener. The leg region HD called them legs. The feet region HD called them feet. The Anal region HD called it a butt. The Arms HD called them arms. The neck region HD called it a neck. Taylor proceeded with the interview asking HD if she had ever gotten kisses, to which HD stated yes. Taylor asked HD from whom she received kisses and HD stated her mother gave her kisses. Taylor asked HD where her mother gave her kisses and HD stated on her cheek and her mouth. Taylor asked HD if the kisses where good kisses or bad kisses and HD stated good. Taylor asked HD if she had ever received kisses that where bad and HD stated yes she received kisses from her daddy, Charles that where not good. Taylor asked HD why the kisses where not good and HD stated that her daddy kissed her on her "bo-bo"( vagina). HD further states that her father would kiss her on her "bo-bo" whenever Daddy's girlfriend Mandy and Illiana would leave. HD states that the latest event happened on January 2, 2010 at her dad, Charles', house. HD states that this day she was sitting on the couch, in the living room and her dad kissed her "bo-bo"( vagina). HD goes on to state that this and other sexual things have happened several times since HD was 4 years old. HD stayed with her father Charles and his girlfriend Amanda over Christmas break and HD disclosed to Taylor that several bad things happened during her stay. HD states that on one occasion her father, Charles took his clothes off and then took her clothes off, because she was to scared to, then laid her on his bed and climbed on top of her. HD states and showed Taylor, on anatomically correct dolls, that her father climbed on top of her and put his "wiener" in her "bo-bo". Taylor asked HD what he did when he put it in and HD stated and motioned with the dolls that he pushed it in hard and that it hurt really bad. Taylor asked HD what her father Charles did while he was on top of HD and HD stated and showed that he moved up and down. Taylor asked HD how long this would go on and HD stated for a few minutes. Taylor asked HD if she had ever seen anything come out of Charles' wiener and HD stated no. Taylor asked HD if her dad made her do anything else that was bad and HD stated that her dad would put his wiener in her mouth. Taylor asked HD what happened during this and HD stated that her dad would put his wiener in her mouth and that she would swirl her tongue around it. HD made a swirling motion with her tongue and showed Taylor. HD also stated that her dads "wiener squirted in her mouth and that the stuff that cam out was "kinda yellow" in color and tasted weird. Taylor asked HD what she did with the stuff and HD stated she spit it in the toilet. HD was asked how she knew to spit it in the toilet and she stated that she just knew. HD goes on to state that this has happened several times but that Charles only squirted stuff in her mouth once. HD also states to Taylor that this stuff happens every time Mandy and Illiana leave to go to the store. HD states that her father kisses her "bo-bo" and other things all the time.

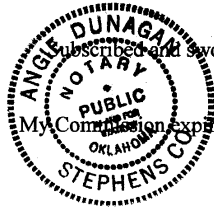
An exam was set for HD on 01-13-2010 at 0800 with Dr. Waters' office and the exam shows that there is evidence consistent with and suspicious for prior penetration. That Dr.

Waters also reported with traction on the Labia the Hymen was viewed and Waters' was not able to see any Hymenal Tissue posteriorly. Cheek swabs were taken from HD for DNA comparison on possible evidence found during a search of Charles' residence.

Investigation on Charles Dyer shows that Dyer has ties to several Militia groups and that Dyer is a flight risk. Dyer also has ties to California.

Based upon this information, the undersigned prays that this Honorable Court issue a finding of fact that probable cause exists to believe that a crime has been committed and that there is probable cause to believe the defendant(s) above named committed that crime. That the crimes are those of Rape 1<sup>st</sup> degree Title 21 Oklahoma Statute 51.1(A) one count, two counts Forcible Sodomy Title 21 Oklahoma Statute 51.1(A). And that the defendant Charles Dyer was arrested for the same.
