molestation. Was corrected when the second attorney took over the case. We told the first attorney it was incorrect but he chose to ignore it and said it didn't make any difference. When we went to the preliminary hearing the State added the possession of the stolen rifle on Friday before the Tuesday hearing and then added the possession of the stolen M203 grenade launcher (was found not guilty by a jury in Federal Court of knowing that it was a grenade launcher, he thought it was a flare launcher).
